PRESIDENT'S MESSAGE





Join the U.S. International Council on Disabilities and make waves.

Disability rights matter.

Dear Members and Friends of USICD,

Aloha once again from Honolulu! It has been a busy year for the U.S. International Council on Disabilities (USICD). Although we continued to work remotely and depended a great deal on Zoom, our relationships and partnerships have been strengthened. We are a respected participant and sought-after resource in disability rights discussions. We are willing to take on new challenges. We welcome opportunities to educate others. We highly value, as we listen, what we learn from others. Sometimes I see USICD as throwing pebbles into a water. When one hits the water, the ripples begin and expand. I hope when you read this annual report you will decide to help us make ripples and ideally waves in 2022!

On October 15th, our Executive Director met with the White House Director of Disability Policy to discuss making the Office on International Disability Rights a permanent office and our preference that the office be led by an Ambassadorat-Large. On October 28th, President Biden's announced the appointment of the new Special Advisor on International Disability Rights, Sara Minkara. We look forward to a new energy in the Department of State, however our work is not complete. Let me explain.

For six years USICD has been advocating for a permanent office, with staff and a budget. During the Obama Administration, Judith Heumann, a member of our board, served as the Special Advisor at the discretion of the President. We pushed then, through the Trump Administration, and now, for a strong leader, a robust budget, and an experienced staff. We were successful in getting legislation introduced in Congress during President Trump's tenure, but it didn't make into law. Currently, a House version is being promoted within the State Authorization Act instead of as a free-standing bill. In the Senate, the principal sponsor, Senator Bob Casey of Pennsylvania, seeks a swelling of grassroots support and Republican co-sponsors, prior to introduction. So, USICD is looking for help from you! The case for a permanent Office on International Disability Rights led by an Ambassador-at-Large has been made many times in legislation, letters, talking points, and Op Eds: it would strengthen our commitment to human rights internationally; create expertise within the diplomatic corps on the value of addressing and supporting disability rights across the globe; and contribute to the reduction in poverty and abuse of people with disabilities in developing countries.

One area in which we are experiencing some real progress is in deinstitutionalization of children with disabilities overseas. Working in partnership with Disability Rights International and its leader, Eric Rosenthal, a member of our board, we provided consultation to the United Nations and others to make the case for and educate governments on

the moral and economic imperative to keep children with disabilities with their families with tested, appropriate supports.

With an influx of Afghans to the U.S., over 100,000, we have learned that at least 20 percent are people with disabilities. USICD is working closely with the Department of State and the Department of Homeland Security on the evacuation and resettlement of Afghans with disabilities, especially Afghans who attended our 2017 disability rights conference held in partnership with the Embassy of Afghanistan. Our board secretary and CEO of the Eastern Oregon Center for Independent Living, Kirt Toombs, is working on sharing with federal officials, a list of disability organizations interested in assisting with the resettlement of Afghans with disabilities.

This report captures other activities in which USICD has engaged in the last year – webinars, training, meetings and partnership initiatives, and fund-raising efforts. With regard to the latter, for example, I created a shop on Etsy.com, the LeftBrainArtStudio, where I sell digital prints I have created; and if you use Amazon Smile and name the United States International Council on Disabilities as the nonprofit you endorse, a percentage of your purchase goes to USICD.

Next year, we celebrate our 30th anniversary! We will continue advocating for an Office on International Disability Rights, the de-institutionalization of children and adults with disabilities, host more webinars, provide more online training courses, and convene even more meetings to address the needs of the global population of people with disabilities and represent them at high level international forums and events. I hope you will do three things within the next 12 months: 1) join USICD or renew your membership and give a membership as a gift to someone else; 2) buy a ticket and give a ticket as a gift to our gala, December 2, 2021; details at <u>www.usicd.org</u>; and 3) consider partnering with us or supporting us through the platforms I mentioned when you shop.

We are living in challenging times. We need to address climate change. We are experiencing negative divisions because some prefer to emphasize our differences rather than our common humanity. We operate in silos rather than reaching out to others to increase the volume of our collective voice and strengthen our impact. Please join USICD and help us make big waves in 2022! There will be no limit to our combined influence if we find ways to work together.



TREASURER'S REPORT


A community of funding and project partners has made USICD's work possible. General operating support and program grants for USICD's education activities have formed a core of USICD's grant funding.

USICD has consistently seen a drop in membership since 2014 in both organizational and individual members. Membership particularly surged during the campaign for U.S. ratification of the CRPD with an increase in individual members. Membership today spans 26 states and the District of Columbia, and includes centers for independent living, academic departments, protection and advocacy organizations, international development actors, and a breadth of others who are all committed to the fundamental rights of persons with disabilities.





