# PRESIDENT'S MESSAGE



#### Dear Members and Friends of USICD,

It has been another busy and exciting year for USICD and my first as USICD's new President! First, let me say that USICD is sad at the passing of our long-time champion and board member, Judy Heumann.

In 2023, we continued our partnership with USICD Member, Disability Rights International, on advocating for the passage of the International Children with Disabilities Protection Act. In 2024, we will continue our Hill, National, and grassroots advocacy efforts on this legislation and will keep our members informed on its progress. We also continued our push for a permanent Office of International Disability Rights led by an Ambassador-at-Large at the U.S. Department of State.

Just this month, we received an invitation from USAID to provide comments on their draft

Disability Policy. Our USICD Policy Committee is preparing comments and USICD has invited the Consortium for Constitutents with Disabilities (CCD) International Task Force and the National Council for Independent Living's Candace Cable at the 2023 UN International Subcommittee to include their feeback.

Also this year, USICD received an Significant Contributions award from Rehabilitation International (RI) for our inclusive education training held in Maputo, Mozambique. USICD Board Member and RI Treasurer, Susan Parker, and our Executive Director, Isabel Hodge, traveled to Beijing, China in May to attend the RI Centennial Celebration and accept the award.

This was the final year of executing of our five-year strategic plan. In 2024, the USICD Board of Directors will revisit the plan and work to ensure feedback is received from our members, allies, and sponsors. This next year is also an important national election year. We must ensure people with disabilities and the barriers that continue to impact their daily lives are discussed, prioritized, and the values and principles we have here in the United States are reflected in our Federally-funded programs and services provided overseas. Also, in 2024, we are holding a webinar, in partnership with the Eastern Oregon Center for Independent Living (EOCIL), on the Convention on the Rights of Persons with Disabilities for U.S. Audiences.

Thank you for taking the time to read our annual report. Reach out to us at any time. We are a membership-based disabled-led organization. We advocate. We provide training and educate others. We convene meetings to advance international disability rights and represent our members and allies in the work that we do at the United Nations and other national and international fora. Please encourage others to become members of the United States International Council on Disabilities.

# A FEW 2023 KEY ACHIEVEMENTS

Our key achievements this year are a direct result of the hard work of our USICD Board, staff, members, and volunteers:

- Partnered with Disability Rights International on the continued advocacy for the International Children with Disabilities Protection Act of 2023 and engaged with national and grassroots organizations.
- Continued advocacy on Office of International Disability Rights Act.
- Participated in the US Steering Group for the International Initiative for Disability Leadership (IIDL).
- Met with the Centre for Sports and Human Rights.
- Signed on to:
  - Letter urging the VA to pause foreclosures during the VA Servicing Purchase Implementation
  - o Department of Justice Title II regulations
  - o Thank You Letter to Senators Casey and Scott for introducing the Veterans Accessibility Act
  - CCD letter to ban electric shocks.
  - Letter to leaders of the House of Representatives to urge Congress to pass funding for the country's disaster response and recovery efforts.
- Co-chaired the Consortium of Citizens with Disabilities (CCD) International Ad Hoc Working Group with USICD member, the World Institute on Disability (WID).
- Provided legislative updates at the monthly National Council on Independent Living (NCIL) International Subcommittee meetings.
- Attended the US Global Leadership Coalition's Impact Forum and met with State of Virginia Representatives and Senators on global foreign policy issues.
- Upon request, participated in UN and USAID Consultations.
- At the U.N., participated in the Civil Society Forum and co-sponsored three side-events at the Conference of State Parties (COSP):
  - Afghan Women with Disabilities
  - From institutions to community: Promotion of Independent Living
  - o Movement and Cohesion in the Disability, Peace, and Security Agenda
- Collaborated with advocates from Afghanistan on a letter to the UN Secretary General on Emphasizing the Rights of Afghans with Disabilities.
- Traveled to Beijing, China in May to attend Rehabilitation International's Centennial Celebration and receive their award for significant contributions for USICD's RI-funded inclusive education training held in Mozambique.
- Attended the RI General Assembly meeting in December.
- Attended Intellectual and Developmental Disabilities (IDD) organizations' CEO Meetings.
- Attended the Launch of the Special Rapporteur's Thematic Report on Enhancing the Protection of Persons with Disabilities During Military Operations in Armed Conflict
- Presented US Institute of Peace Disability Inclusion and the Women, Peace and Security Agenda Learning Exchange.
- Participated in the Disability Museum Working Group.
- Worked on the updating of the Global Disability Rights Library.
- Attended the Disabled Peoples International (DPI) World Council Meeting in Busan, South Korea.
  Isabel Hodge was elected as the Secretary of DPI World Council Board of Directors.
- Attended the DPI North America and the Caribbean (DPI NAC) quarterly meetings. Isabel Hodge serves as the Vice President of DPI NAC.
- Began work on Accessible Conferences and Large Events Training Course

# TREASURER'S REPORT

A community of funding and project partners has made USICD's work possible. General operating support and program grants for USICD's education activities have formed a core of USICD's grant funding.

An independent audit of USICD's 2022 financial statements conducted by AAL Certified Public Accountants found that all financial records were accurate and maintained in conformity with standard accounting principles accepted in the United States. A copy of this audit is available upon request.

USICD has consistently seen a drop in membership since 2014 in both organizational and individual members. Membership particularly surged during the campaign for U.S. ratification of the CRPD with an increase in individual members. Membership today spans 26 states and the District of Columbia, and includes centers for independent living, academic departments, protection and advocacy organizations, international development actors, and a breadth of others who are all committed to the fundamental rights of persons with disabilities.




