PRESIDENT'S MESSAGE



USICD President Candace Cable, PLY

Hello Everyone!

Thank you for your continued belief in and support of the U.S. International Council on Disabilities (USICD). Your generous contributions with your membership dues and your ideas are an important mainstay for USICD to flourish.

Thank you to Isabel Hodge the Executive Director of USICD for compiling this annual report and for all her work throughout the 2024 year.

This year, 2024 was my tenth year on the Board of Directors for USICD. I first discovered USICD while I attended the 2012 Conference of the States Parties (COSP) for the United Nations Convention on the Rights of Persons with Disabilities.

I was one of a few Paralympians attending the COSP and during a side event I sat next to David Morrissey, the then Executive Director of USICD. We struck up a conversation about my idea that Paralympic sport is an unused opportunity to expand the narrative

on the importance of ratification of the CRPD.

I talked about how Article 30 of the CRPD states that sports, recreation, leisure, and culture are human rights for everyone and that we could use this to attract more people to USICD's ratification efforts. But many folks still felt sports were trivial compared to building policy and creating employment. But I felt that sport could amplify all the Articles their implementations if given a chance.

I devised several ideas for initiatives focusing on Paralympic athletes and recreational sports for Disabled people so we could find ways to work together. During the 2013 COSP for the CRPD myself, Ohana, Bumble Bee wheelchairs and USICD held a side event on Article 20 of the CRPD that ensures personal mobility equipment is needed to create the greatest possible independence for people with disabilities.

In 2014, I was contracted by the US State Department to visit Armenia and Georgia US Embassy's to speak about sport diplomacy. I would also attend the Paralympic winter games in Sochi, Russia, as a journalist following my State Department work.

David asked me to find anything I could that had to do with the CRPD, while on my adventure and send it back to him. I was aware that during the 2014 Paralympic Games there would be a wall erected supporting the CRPD in the Athlete Village because a lot of human rights violations that were happening in Russia during this time. I sent video back to David of the CRPD wall being dedicated by the International Paralympic Committee and signed by athletes from all over the world.

David was able to use the video I sent him and then we had an idea bring Paralympic athletes to Capitol Hill in Washington DC for the final push to meet the Senators and inspire them to vote for ratification of this CRPD. Four athletes, including myself came to Capitol Hill, with our medals and met with Senators and had high hopes for ratification. We missed ratification by only a few votes.

These are just a few stories of what I brought forward to build USICD's authority on international relationships. I'm sharing this with you because it's important for you to be involved and use your imagination and talents to expand USICD's reach, education, advocacy, and convening opportunities as a member of USICD.

I hope that you will decide to give deep thought to what initiative you want to bring forward to support the growth of USICD. Once you decide what you want to bring forward, then determine how you can do this and work with USICD Board members or become a Board member.

It has been a great learning experience for me to have been a Board member for the past decade. This is my last year as a USICD board member. I thank everyone for our time working together and I am grateful for the experiences that I had with my fellow Board members and USICD's Executive Director. I wish everyone great success.

A FEW 2024 KEY ACHIEVEMENTS

Our key achievements this year are a direct result of the hard work of our USICD Board, staff, members, and volunteers!

Advocacy

- Partnered with Disability Rights International on the continued advocacy for the International Children with Disabilities Protection Act and appropriations for the Bill and engaged with national and grassroots organizations, as well as members of Congress.
- Signed on to over 20 Consortium for Citizens with Disabilities letters and statements.
- Signed a letter to the White House to request increased support for essential programs that prevent and respond to violence against children globally in the FY2026 President's Budget Request.
- Signed a letter to demonstrate our support to Senator Shaheen and Senator Murkowski for their continued leadership for girls vis-à-vis getting this language in the U.S. Global Strategy to Empower Adolescent Girls
- Attended a two-day workshop held at the German Permanent Mission to the United Nations in advance of the April 2024 meetings of the UN General Assembly 6th Committee
- Upon request, participated in UN and USAID Consultations.
- Collaborated on A Joint Proposal for a White House-led Initiative for Children and Youth Globally
- Provided legislative updates at the monthly National Council on Independent Living (NCIL) International Subcommittee meetings.

Training & Education

- Met with USAID to discuss the Global Disability Rights Library.
- Launched the USICD Learning Hub website
- Developed content for the Planning Accessible Conferences and Large-Scale Events Training Course and toolkit.

Convening

- Held Reimaging USICD meetings to discuss USICD's priorities.
- Hosted a webinar titled "Understanding the History & Benefits of the UN CRPD.

Representation

- Co-chaired the Consortium of Citizens with Disabilities (CCD) International Ad Hoc Working Group with USICD member, the World Institute on Disability (WID).
- Facilitated a discussion on the State Department's International Disability Rights Team at the 2024 M-Enabling Summit
- Participated in AUCD International Special Interest Group meetings.
- Attended the DPI North America and the Caribbean (DPI NAC) quarterly meetings. Executive Director Isabel Hodge serves as the Vice President of DPI NAC.
- Attended the Disabled Peoples International World Council Board of Directors meetings. Executive Director Isabel Hodge serves as the Board Secretary.
- Participated in the Disability Museum Working Group.
- Attended Rehabilitation International's World Congress 24 Rehabilitation Work and Employment which was held in September in Abu Dhabi. Over 81 countries were represented, with 1000 people attending.
- At the U.N., participated in the Civil Society Forum and side events at the Conference of State Parties (COSP). Isabel Hodge provided opening remarks at an independent living side event.

TREASURER'S REPORT

A community of funding and project partners has made USICD's work possible. General operating support and program grants for USICD's education activities have formed a core of USICD's grant funding.

USICD has consistently seen a drop in membership since 2014 in both organizational and individual members. Membership particularly surged during the campaign for U.S. ratification of the CRPD with an increase in individual members. 







